European scientists to debate ageing society challenges at the 11th EU Hitachi Science and Technology Forum

21st April 2008 - Hitachi Europe Ltd. today announced that the 11th EU Hitachi Science and Technology Forum will be hosted at Sheraton Arabellapark Hotel in Munich on 26th and 27th April 2008, bringing together European experts, Forum members, representatives from industry, NGOs and academia to debate the topic: "Ageing Society and Technology".

- 5. "Mobility" by Ann Frye, Ann Frye Ltd

The discussions and conclusions of the Forum will also be published and distributed to the European Commission, members of the European Parliament, relevant authorities in member states of the European Union, journalists, universities and Hitachi's partners in Europe.
