Notification of Tender Offer for Shares of Subsidiary

Tokyo, Japan, November 17, 2017 --- Hitachi, Ltd. (TSE:6501, “Hitachi”) announced in its press release dated October 11, 2017 titled “Notification of Commencement of Tender Offer for Shares of Subsidiary” (“Hitachi’s October 11 Press Release”) that HKE Holdings G.K. (Executor: William Janetschek, “HKE”) has commenced a tender offer for common shares of Hitachi Kokusai Electric Inc. (President and Chief Executive Officer: Kaichiro Sakuma, “Hitachi Kokusai”) from October 12 (the “Tender Offer”), and the period of the Tender Offer is until November 24, 2017.

According to the “Announcement Regarding the Tender Offer for the Shares of Hitachi Kokusai Electric Inc. (Securities Code 6756)” announced by HKE today, HKE believes that the Tender Offer purchase price and other economic terms of the Tender Offer are optimal terms providing Hitachi Kokusai’s shareholders with an opportunity to fairly sell their shares in Hitachi Kokusai. Further, according to the “Announcement regarding the Tender Offer for the Shares of Hitachi Kokusai Electric Inc. by HKE Holdings G.K.” announced today by Hitachi Kokusai, to date, Hitachi Kokusai has not received any acquisition proposal from any third party since October 11, 2017, the date on which the commencement of the Tender Offer was announced, other than the Transaction (defined in Hitachi’s October 11 Press Release) proposed by HKE.

We hereby announce that the Transactions, including the Tender Offer, have been agreed after multiple discussions and negotiations among Hitachi, Hitachi Kokusai, HKE, and HVJ Holdings Inc. (Representative Director and President: Tatsuo Kimura, “HVJ”) and that there is no change in our intention to execute the Transactions in accordance with the Original Basic Agreement and the Amendment Memorandum (each defined in Hitachi’s October 11 Press Release) executed among Hitachi, HKE, and HVJ.
